# PRIVACY POLICY NOTICE

We at Central Loan Company, LLC are committed to protecting your privacy and non-public personal information about you. We have prepared this notice to inform you about the information we collect and how we use the information collected.

## Confidentiality of Present and former Consumer Information

Our employees and our service providers handle your non-public personal information so that we may offer or provide our services to you in addition to processing and servicing your accounts. We value our customers and therefore, don't sell customer information or share it with organizations outside our company for their own marketing purposes. Your personal information is never released to people or entities outside of this company except as agreed to you by or as required by law.

## Information Collected

In the process of providing you with financial services we collect certain personal information about you including:

Information that you provide to us on credit applications, title registration and/or other forms, such as your name, address, date of birth, telephone and social security numbers, assets, debts and income

Information from credit reporting agencies regarding your credit history or creditworthiness.

Information about you that we acquire from other third parties to assist us in evaluating your credit application (i.e. employment, income verification, etc.)

We rely on the credit bureau reports to evaluate our customer's creditworthiness and to protect our customers from fraudulent conduct. When you complete a credit application you are expressly authorizing us to obtain a credit bureau report about you.

We stress that confidential nature of information being shared.

## Shared Information Uses

The only reason information will be shared is to provide you with our products and services you have requested. We will share information to comply with reporting or other legal requirements as well as to conduct regular business. We may share information with financial service providers such as insurance companies and consumer reporting agencies.

We may disclose personal information as necessary to facilitate transactions: i.e., to collect funds on a check.

We also disclose personal information as required or permitted by law; i.e., in response to a subpoena or garnishment, or a credit agency.

In accordance with the Fair Credit Reporting Act, we will share information regarding the status of your account with credit bureaus.
